4.Taking into consideration that the petitioner is complying the condition regularly and the health condition of the petitioner, the condition no.5(b) imposed on the petitioner directing him to appear before the respondent police daily at 10.00 am., until further orders is alone modified to the effect that the petitioner shall report before the respondent police at 10.00 a.m., in every first working day of English Calendar month until further orders. All other conditions shall remain unaltered.

5.Accordingly, the Criminal Miscellaneous Petition is allowed.
