The present transfer civil miscellaneous petition has been filed by the wife seeking to transfer H.M.O.P.No.50 of 2022 on the file of the Family Court, Tiruppur to Sub Court, Thuraiyur, Trichy.

2. According to the learned counsel for the petitioner/wife, she is permanently residing at Thuraiyur along with her parents and 1 and ½ year old daughter. She finds it difficult to travel on every occasion to attend hearings in Family Court, Tiruppur. The learned counsel appearing for the petitioner further submits that the wife has filed H.M.O.P.No.69 of 2022 for restitution of conjugal rights and the same is pending before the Sub Court, Thuraiyur.
