ORDER

This Criminal Original Petition is filed under Section 482 of Cr.P.C. by the petitioner / *defacto* complainant seeking for a direction to the respondent Police to complete the investigation in Crime No.222 of 2022 for the offences under Sections 294 (b), 323, 324 and 506 (2) of I.P.C. as expeditiously as possible and file the final report.

2. Learned counsel for the petitioner submits that, on a complaint given by the petitioner, the respondent Police have registered FIR in Crime No. 222 of 2022 for the offences under Sections 294 (b), 323, 324 and 506 (2) of I.P.C. on 27.06.2022 and submitted further that, in spite of registration of FIR, no substantial progress in the investigation, thereby, sought for suitable directions.
