ORDER

The petitioner is the son of the detenu, namely, Manoharan, aged about 47 years, S/o.Maharajan. The detenu has been detained by the 2nd respondent by his proceedings in Detention Order No.86 of 2022 dated 30.08.2022, holding him to be a "Goonda", as contemplated under Section 2(f) of Tamil Nadu Act 14 of 1982. The said order is under challenge in this Habeas Corpus Petition.

2.The learned Additional Public Prosecutor appearing for the respondents has submitted that the detention order, which is impugned

herein, has already been revoked by the competent authority. Therefore, the prayer sought for herein has become infructuous.
