This Petition has been filed seeking orders to restore the Criminal Revision Case in Crl.R.C.(MD)No.807 of 2016, which was ordered to be dismissed for non-prosecution on 25.06.2021.

2.This Court Passed an order on 25.06.2021, which reads as follows:

“When the matter was taken up for hearing on 29.03.2021, there was no representation on behalf of the petitioner. Hence, the matter was posted under the caption “for dismissal” on 08.04.2021.
