Petition filed under Article 226 of the Constitution of India to issue a writ of Habeas Corpus calling for the records from the second respondent in M.H.S.Confdl.No.147/2022, dated 29.08.2022, by setting aside the said order of detention passed by the second respondent and setting the detenu,

namely, Murugesan, S/o.Paramasivan, aged 23 years, at liberty, now detained in the Central Prison, Palayamkottai.

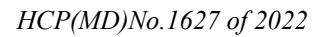

ORDER

(Order of the Court was made by **M.S.RAMESH, J.**)

The petitioner is the mother of the detenu viz., Murugesan, S/o.Paramasivan, aged 23 years. The detenu has been detained by the second respondent by his order in M.H.S.Confdl.No.147/2022, dated 29.08.2022, holding him to be a "Goonda", as contemplated under Section 2(f) of Tamil Nadu Act 14 of 1982. The said order is under challenge in this Habeas Corpus Petition.

2. We have heard the learned counsel appearing for the petitioner and the learned Additional Public Prosecutor appearing for the respondents. We have also perused the records produced by the Detaining Authority.



5. On carefully going through the detention order, it is seen that the detaining authority was aware of the fact that no bail application was filed by the detenu. However, the detaining authority took into consideration the order passed in CrI.M.P.No.1805/2018 and came to the conclusion that there is a likelihood of the detenu coming out on bail, since in similar cases, bails

are granted by the appropriate Courts. Perusal of the order passed in Crl.M.P.No.1805/2018 shows that the learned Principal Sessions Judge, Tirunelveli, after considering the fact that substantial part of investigation was over and the accused therein namely, Manikantan @ Mani had no previous antecedents, had granted bail to him and hence, that bail order relied upon by the detaining authority cannot be considered to be a similar one. Even there is no material placed before this Court to prove that the relatives or friends of the detenu have filed bail application for the detenu and therefore, the apprehension of the detaining authority that there is a real possibility of the detenu coming out on bail, is unfounded.

6. In view of the above, the detention order suffers from non-application of mind on the part of the detaining authority and therefore, the same is liable to be interfered with by this Court. The impugned detention order is, therefore, liable to be quashed.

7. In the result, the Habeas Corpus Petition is allowed and the order of detention in M.H.S.Confdl.No.147/2022, dated 29.08.2022 passed by the second respondent is set aside. The detenu, viz., Murugesan,

S/o.Paramasivan, aged 23 years, is directed to be released forthwith unless his detention is required in connection with any other case.
