2. When the matter was taken up for hearing, learned Government Advocate (Criminal Side) on consulting with the respondent Police submitted that if fresh application is filed by the petitioner before the respondent Police and the same will be considered.

In view of the above, this Writ Petition is disposed of, directing the petitioner to approach the respondent Police afresh and file application by giving all the details in respect of the hygiene, play grounds, accommodation to the players, toilets, medical facilities like ambulance, food, refreshment etc and
