ORDER

This writ petition was filed challenging the Special Assessment Notice No.533 and the Proceedings in Na.Ka.No. 2479/2014/A.1, dated 19.03.2015 issued by the Commissioner, Sankarankoil Municipality, directing the petitioner to pay the property tax due to the respondent Municipality.

2.Today(02.11.2023), when this writ petition is taken up for hearing, the learned counsel appearing for the petitioner has filed a memo stating that total demand made by the respondent Municipality as per the notice, dated 31.10.2023 is Rs.10,90,545/- and pending this writ petition, pursuant to the interim order granted by this Court on 30.04.2015, the petitioner has made the following payments to the respondent Municipality:-
