ORDER

This writ petition has been filed for issuance of writ of mandamus directing the respondents to act upon the representation made by the petitioner on 16.11.2019, wherein the petitioner is seeking for disbursement of the amount payable to him for the works done by him on the basis of the contract given by the Panchayat Union.

2. The grievance of the petitioner is that the Panchayat Union had allotted the work to the petitioner by entering into a contract and the petitioner had also completed the work. According to the petitioner, a sum of Rs.5,00,000/- was due and payable to the petitioner and the said amount was not paid. The petitioner made a representation in this regard and since the same was not considered, the present writ petition has been filed before this Court.

Whatever amount is due and payable to the petitioner for the works done by him as per the available records shall be settled to the petitioner within a period of six weeks from the date of receipt of a copy of this order.

5. This writ petition is disposed of accordingly. No costs.
