This petition has been filed seeking to quash the impugned FIR in Crime No. 14 of 2020 on the file of the 1<sup>st</sup> respondent police.

2.The contention of the petitioners is that based on the complaint lodged by the 2<sup>nd</sup> respondent, the 1<sup>st</sup> respondent registered the First Information Report in Crime No.14 of 2020 for the offences punishable under Sections 120B, 419, 468, 506(i) of IPC against the petitioners. Seeking quashment of the same on various grounds this petition has been filed.
