respondents 3 and 4 to survey the petitioner's land to an extent of 2072 sq. ft. situated in Survey No.208 at Tallakulam, Madurai North Taluk, Tallakulam Sub District, Madurai North Registration District, Madurai District, now Door No.47, Bharathiar 1st Street, Ward No.3, K.Pudur, Madurai Corporation and lay boundary stones based on the petitioner's representation dated 26.07.2023 within the time limit that may be stipulated by this Court.

ORDER

The petitioner has submitted an application dated 26.07.2023 to the respondents 3 and 4 requesting them to survey her land situated in Survey No.208 at Tallakulam, Madurai North Taluk. Since the said application has not been considered, the present writ petition has been filed.

2. Mr.P.T.Thiraviam, learned Government Advocate, on instructions, submits that based on the petitioner's application, the

survey officials went to the petitioner's land for conducting survey on 18.08.2023, however, survey could not be completed as there was an objection from the adjacent land owners.

3. If there is any objection from the adjacent land owners, the Survey Officer is expected to issue a notice to them and thereafter, he has to take a decision.

4. Accordingly, this writ petition is disposed of with a direction to the respondents 3 and 4 to issue a notice to the objectors as per Section 10 of the Tamil Nadu Survey and Boundaries Act, 1923 and thereafter, take a decision in accordance with law, within a period of twelve weeks from the date of receipt of a copy of this order. No costs.
