2.The contention of the petitioners is that based on the complaint lodged by the 2nd respondent, the 1st respondent registered the First Information Report in Crime No.284 of 2022 for the offences punishable under Sections 294(b), 323, 506(i) of IPC.

3.When the matter is taken up for hearing, the learned Additional Public Prosecutor would submit that after completing the investigation final report has been filed before the learned Judicial Magistrate,Melur, and the same was taken cognizance in C.C.No.294 of 2023.
