2.The learned counsel appearing for the petitioner by referring the proceedings of the Tahsildar, Sivagangai submits that the seventh respondent has tampered with certain documents and participated in the election. This has been confirmed by the Tahsildar in his proceedings and the same has been referred to the Revenue Divisional Officer for necessary action. The Revenue Divisional Officer, who is the authority to take action has not taken any action. Therefore, the petitioner is before this Court.

3.Mrs.D.Farjana Ghoushia, learned Special Government Pleader, who takes notice for the official respondents submits that the representation of this petitioner and the proceedings of the Tahsildar
