This criminal original petition has been filed seeking to quash the FIR in Crime No.44 of 2022 on the file of the 1st Respondent Police.

2.The contention of the petitioners is that based on the complaint lodged by the 2nd respondent, the 1st respondent registered the First Information Report in Crime No.44 of 2022 for the offences punishable under Sections 147, 148, 427, 379 of IPC.

3.When the matter is taken up for hearing, the learned Government Advocate (Crl. Side) would submit that after completing the investigation final report has been filed before the learned Judicial Magistrate, Usilampatti, through e-filing and the same has not been taken cognizance so far. Hence, the prayer sought for in this petition has become infructuous.
