Earlier, by the proceedings, dated 29.03.2023, the District Collector, Tenkasi District, has recommended cancellation of house site patta granted in favour of 35 beneficiaries, pursuant to the Scheme for allotment of free house sites to houseless people. Consequently, a representation is submitted by the petitioner. The fourth respondent has now initiated proceedings, to conduct enquiry. The above writ petition is filed to direct the official respondents to take action for resumption of lands from allottees.

4. However, the petitioner has filed the above writ petition without impleading the beneficiaries, who are interested in this proceedings. Since any order passed by this Court will affect the interest of such persons, this writ petition is dismissed on the ground of non-joinder of necessary parties. However, it is open to the petitioner to file a fresh writ petition if he wants to pursue his remedy after impleading all the necessary parties. No Costs.
