It is submitted by learned counsel for the petitioner that there are disputes between the petitioner and private person in respect of the immovable property and the said person has cheated the petitioner, thereby, the petitioner has filed a complaint in C.S.R.No.85 of 2023 and the respondent Police have not taken any action, thereby, sought for suitable directions.

3. Learned Government Advocate (Criminal Side), on the other hand, submits that, the enquiry was conducted in C.S.R.No.85 of 2023 and on hearing of both sides, the enquiry in C.S.R.No.85 of 2023 was closed after the undertaking given by the petitioner that he will approach the appropriate forum.

4. Since the petitioner himself has given undertaking that he will approach the appropriate forum and since dispute between the petitioner and the third parties is purely civil in nature, no orders can be passed in this case. Therefore, the writ petition stands dismissed. No costs.
