ORDER

This Criminal Original Petition is filed under Section 482 of Cr.P.C. Seeking for a direction to the respondent Police to provide police protection by considering the representation of the petitioner, dated 19.08.2023.

It is submitted by learned counsel for the petitioner that the petitioner borrowed some money from the fifth respondent and discharged most part of it and in respect of balance of the amount and interest, the respondent No.5 has been threatening the petitioner and sent a message that he will cut the throat of the petitioner, in case, if he pays no interest. Basing on which, a representation has been given to respondent Nos.2 and 3 Police, but, no action has been taken so far.
