ORDER

[Order of the Court was made by S.M.SUBRAMANIAM, J.]

This contempt petition has been filed alleging willful disobedience of the order, dated 12.07.2022, made in W.P.(MD) No.1038 of 2022.

2. This Court, by order dated 12.07.2022 in W.P.(MD) No.1038 of 2022, directed the Tahsildar, Vendasandur Taluk, Dindigul District, to conduct a survey and in the event of identifying any encroachment, the same was directed to be removed.

3. Learned Government Advocate appearing for the respondents, based on the instructions given by the Tahsildar, Vendasandur Taluk, submitted that a survey, as directed by this Court, was conducted and the encroachments identified by the authorities were removed by following the procedures as contemplated. To substantiate the said submission, the learned Government Advocate has furnished a copy of the letter dated
