3. Considering the aforesaid facts, I.D.O.P.No.174 of 2022 pending on the file of the Family Court, Chengalpattu, is hereby withdrawn and transferred to Family Court, Nagercoil, Kanyakumari District. The learned Judge, Family Court, Nagercoil, is directed not to insist upon the personal appearance of the respondent/husband, unless it is compulsorily required.

5. With the above observation, the Transfer Civil Miscellaneous Petition is allowed. No costs. Consequently, connected Miscellaneous Petition is closed.
