2. According to the petitioner he has been complying with the condition from

The learned Government Advocate(Crl.Side) appearing for the respondent also admitted that the petitioner has been complying with the conditions from 06.08.2023 without fail as directed by this Court, however he objected to relax the condition on the ground that the investigation is still pending.

4.Considering the representation made by the learned counsel appearing for the petitioner and the learned Government Advocate(Crl.Side) and also considering the nature of offence and considering that the petitioner is complying with the condition without fail, this Court is inclined to modify the condition. Accordingly, the condition imposed on the petitioner is modified to the effect that the petitioner shall report before the respondent police @ 10.30 a.m., on the first day of every English Calendar month until further orders.

4.Accordingly, the Criminal Miscellaneous Petition is allowed.
