ORDER

The petitioner, with a grievance that his application to issue a death certificate of his father, who died on 21.06.1990, has not been considered, has filed this writ petition for a Mandamus, directing the second respondent to issue his father's death certificate.

2. Mr.M.Sarangan, learned Additional Government Pleader, who takes notice for the respondents 1 to 3 submits that based on the petitioner's application, enquiry was conducted by the second respondent/the Revenue Divisional Officer, Uthamapalayam and a

recommendation has also been made by the second respondent/the Revenue Divisional Officer, Uthamapalayam, to the third respondent/the Tahsildar, Bodinayakanur, to register the death of the petitioner's father and issue a death certificate. He has also produced a copy of the proceedings of the second respondent dated 28.08.2023 to that effect.

3. Recording the said submission, this writ petition is closed. However, a direction is issued to the 3rd respondent/the Tahsildar, Bodinayakanur, to issue a death certificate of the petitioner's father, based on the recommendation of the Revenue Divisional Officer, Uthamapalayam, within a period of four weeks from the date of receipt of a copy of this order. No costs.
