This Court, by order dated 05.09.2023, has granted an order of interim stay with a condition that the petitioner shall deposit a sum of Rs.7,00,000/- of arrears amount of maintenance pending as of now, on or before 27.09.2023 and continue to pay the monthly maintenance amount awarded by the trial Court till the disposal of the criminal revision case.

2.Today, when the matter was taken up for hearing, without complying the conditional order, the learned counsel for the petitioner seeks an adjournment.

3.In view of the non-compliance of the conditional order passed by this Court on 05.09.2023, the interim stay already granted by this Court stands vacated. Accordingly, this Criminal Miscellaneous petition is dismissed.
