2. While disposing the said Writ Petition, this Court directed the respondents to consider the representation of the petitioner in terms



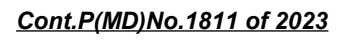

of the settlement arrived under Section 12(3) of the Industrial Disputes Act, between the employees Union and the Management dated 25.09.1986 and 13.04.2015 and accordingly, the respondents are directed to consider the petitioner's representation, dated 24.02.2016 and pass appropriate orders, on merits and in accordance with law, within a period of four weeks from the date of receipt of a copy of the order.

During the course of hearing today, Mr.Veerakathiravan, learned Senior Counsel appearing for the respondents placed the proceedings No.01/PS-P1/TNSTC(Kum)/2023, dated 28.09.2023 issued by the second respondent, appointing the son of the petitioner as Conductor under compassionate grounds in compliance of the order of this Court. It is placed on record.

4. On perusal of the material available on record, it appears that there is some delay in implementing the order of the Court. However, considering the facts and circumstances of the case, this Court intends to take lenient view with regard to delay.
