3. The learned counsel for the petitioners submitted that the petitioners are innocent person and they were falsely implicated in this case and they never committed any offence as alleged by the prosecution.

4. Reading of the First Information Report shows that the country bomb used by the accused persons at that time of making the above said attack.

5. Considering the facts and circumstances and also considering the grievous nature of offence alleged against the petitioners, this Court is not inclined to grant bail to the petitioners. If the petitioners are released on bail, they may abscond, tamper the evidences and it will hamper the investigation process. Hence, this petition deserves dismissal and accordingly dismissed.
