3. In view of the said submission, the Revenue Divisional Officer, Vathirairuppu, is *suo motu* impleaded as a respondent in this writ petition.

4. The petitioner is directed to submit a fresh application along with necessary documents before the Revenue Divisional Officer, Vathirairuppu, within a period of two weeks from the date of receipt of a copy of this order. If any such application is received, the Revenue Divisional Officer, Vathirairuppu, shall consider and dispose of the same, in accordance with law, after providing an opportunity of hearing to the necessary parties, within a period of four months thereon.
