Haryana and Others reported in 2 (2003) 5 SCC 604 and in Civil Appeal No.4954 of 2016 in S.L.P (C) No.2890-2894 of 2016, dated 21.01.2016 and consequently direct the respondents to include the petitioner name in Joint Registrar of Co-operative Societies panel for the year 2021-2022 as per the rules in force.
