Today, when the matter was taken up for hearing, the learned Government Advocate appearing for the official respondents submitted that the official respondents have passed another order, dated 13.01.2016, bringing the school under direct payment. The said order was also challenged. Subsequently, pending writ petition, the official respondents withdrew the direct payment. Now the G.Selva Mariappan was reinstated back into service. It is further submitted that the said G.Selva Mariappan has received salary for the said suspension period. Therefore, nothing survives for adjudication in this matter.

3. In view of the above observations, this Writ Petition is closed. No Costs. Consequently, connected miscellaneous petition is closed.
