WEB COP 2. When the writ petition came up for hearing today, learned Counsel on either side submitted that the petitioner's license has been renewed upto 2023 and therefore, nothing survives for further adjudication in this writ petition.

3. Recording the aforesaid submission, the writ petition in WP(MD)No. 12249 of 2016 stands closed, as no further order is required to be passed.

4. The writ petitions in WP(MD)Nos.12370 of 2016 & 12792 of 2017 are filed as against the orders passed by the official respondents rejecting the petitioner's request for renewal of license. The petitioner also sought for a direction to renew his registration.

5. In view of the order passed in WP(MD)No.12249 of 2016 by recording the submission that the petitioner's license has been renewed upto 2023, these two writ petitions in WP(MD)Nos.12370 of 2016 & 12792 of 2017 are also closed.
