ORDER

This Criminal Original Petition is filed seeking for expeditious completion of trial in S.T.C.No.1133 of 2022 on the file of the learned Judicial Magistrate No.II, Virudhunagar, within a time limit fixed by this Court.

2. It is submitted by the learned counsel appearing for the petitioner that the petitioner is the sole accused in S.T.C.No.1133 of 2022 and on account of pendency of S.T.C.No.1133 of 2022, a lot of hardships have been caused to the petitioner and thereby, he sought for suitable directions.

3. As per "B" Diary, S.T.C.No.1133 of 2022 is posted from time to time as the summons to the accused have not been served. Though the petitioner herein is the sole accused and intends to expedite the trial, instead of appearing before the trial Court on the next date of hearing (i.e.,) 20.09.2023, he has approached this Court for speedy trial of the case.
