dated 20.06.2016 and to constitute an expert committee to the Tuticorin district with representatives from the fishing community as well to undertake a comprehensive filed study about the use of modified purse seine nets of mesh size of 100-108mm, height of 40m and length of 500m being used for fishing from 2 km to 10 km stretch from the shore by 10hp out board motor boat and impact on fishing an ecology and grant exemption to these modified purse seine gear from the ban imposed vide notification in GO.Ms.No.40 Aimal Husbandry and Fisheries (FSV) Department dated 25.03.2000 issued under Section 5(1)(a) of the Tamil Nadu Marine Fishing Regulation Act, 1983 in light of the order dated of this Court in WP.No.1862 of 2015 dated 12.03.2015.
