The petitioner with a grievance that the respondents are laying a drainage channel in the petitioner's patta land has submitted a representation to the respondents and filed this writ petition.

2.Mrs.D.Farjana Ghoushia, learned Special Government Pleader, who takes notice for the respondents 1 & 2 submits that the drainage channel is constructed only in the Government land and not in the petitioner's patta land.
