PRAYER: Writ Petition is filed under Article 226 of the Constitution of India, praying this Court to issue a Writ of Certiorari to call for the records of the second respondent in his proceedings in Na.Ka.No. 42026/H/E2/2016, dated 11.06.2016 and consequential order passed by the 5th respondent in his proceedings in Na.Ka.No.50/2016, dated 19.07.2016 and quash the same as illegal, arbitrary, violation of principles of law.

ORDER

Heard Mr.M.Jothibasus, learned counsel for the petitioner and Mr.V.Nirmal Kumar, learned Government Advocate for the respondents 1 to 4.

2. The challenge in this matter is the order of recovery dated 19.07.2016. The petitioner was appointed as B.T.Assistant in Government High School, Andakulam, Pudhukottai District. In February 2007, the petitioner got higher qualification of M.Phil degree. The incentive was granted from February 2007. While this is so, it appears that the State had issued a Letter bearing No.129, dated 17.07.2013, prescribing a cut off date for the award of incentive relating to M.Phil.,

degree as 18.01.2013. In fact, a Government Order issued prior thereto in G.O.(ID).No.18, dated 18.01.2013 did not prescribe any cut off date to fix the entitlement for receipt of incentive and the Letter dated 17.07.2013 had been issued as a clarification thereto.

3. Thus, as a consequent of clarification dated 17.07.2013, the impugned order has come to be passed on the date as aforesaid seeking recovery of the incentive granted earlier.

4. Straight away the impugned order is liable to be quashed on the strength of the directions issued in the case of *State of Punjab and others etc., vs. Rafiq Masih (White Washer) etc.,* (2015 (4) SCC 334). At paragraph – 12 thereof the Hon'ble Supreme Court prescribes the following directions:

“12. It is not possible to postulate all situations of hardship, which would govern employees on the issue of recovery, where payments have mistakenly been made by the employer, in excess of their entitlement.

Be that as it may, based on the decisions referred to herein above, we may, as a ready reference, summarise the following few situations, wherein recoveries by the employers, would be impermissible in law:

(i) Recovery from employees belonging to Class-III and Class-IV service (or Group C and Group D service).

(ii) Recovery from retired employees, or employees who are due to retire within one year, of the order of recovery.

(iii) Recovery from employees, when the excess payment has been made for a period in excess of five years, before the order of recovery is issued.

(iv) Recovery in cases where an employee has wrongfully been
