4. The learned Government Advocate (Crl.Side) would submit that the request is made by the petitioner to celebrate the above said function on 24.09.2023 and the date is expired. Further, because of some objections made by the another community people, the petitioner's representation dated 24.08.2023 was rejected by the third respondent herein.

5. Whatever it may be, because of some rivalry, Peace Committee Meeting was convened by the Tahsildar, Illuppur, on 10.08.2023, both parties appeared and resolution was adopted advising the parties to arrange the above said function in a private place.

6. Since the date fixed to celebrate the function is expired, this matter has become infructuous. The petitioner is at liberty to make a fresh representation by mentioning alternative date. Let proper
