The above lands belongs to one Chellamuthu and Sundarambal and one of their legal heir, namely Chinnakkalai S/o Chellamuthu has raised certain objections for conducting the survey.

3.Considering the rival submissions made, if the petitioner is having any valid documents, the respondents shall conduct an enquiry as contemplated under section 10 of the Tamil Nadu Survey and Boundaries Act, 1923 and pass necessary orders
