ORDER

During the course of arguments, learned counsel for the petitioner requested the Court to permit him to withdraw this petition as he will file an application before the National Legal Services Authority basing on the compensation scheme for Women Victims / Survivors of Sexual Assault / other crimes 2018.

3. Considering the request of the petitioner, the petitioner is permitted to withdraw this writ petition. Accordingly, this petition is dismissed as withdrawn. However, in case, if the petitioner feels that he could not get the compensation as under the Legal Services Authority Scheme, he is at liberty to approach the Court by filing appropriate petition.
