Considering the facts and circumstances of the case, this Court is inclined to grant interim stay on condition that the petitioner shall deposit 50% of the arrears amount of the maintenance pending as of now to the credit of M.C.No.5 of 2017 on the file of the Family Court (Full Additional in charge), Trichy, within a period of six weeks from the date of receipt of a copy of this order and further, the petitioner shall deposit 50% of the monthly maintenance amount until further orders, failing which the interim stay granted shall stand vacated automatically without further reference to this Court.
