Therefore, if the petitioner approaches the respondents with a fresh representation, it shall be considered in accordance with law.

3.In view of the above submission, this writ petition is disposed of with liberty to the petitioner to submit a fresh representation to the 3<sup>rd</sup> and 4<sup>th</sup> respondents within a period of four weeks from the date of receipt of a copy of this order and if any such representation is received, the 3<sup>rd</sup> and 4<sup>th</sup> respondents shall consider it and pass appropriate orders on merits and in accordance with law within a period of twelve weeks therefrom.
