ORDER

The petitioner seeking a free house constructed by the Tamil Nadu Urban Habitat Development Board has approached the respondent authorities, based on which, she was allotted a house at Rajakur. However, the petitioner was not inclined to accept the same and requested to allot a house at Athikulam, Madurai. Since there is no vacancy in Athikulam, the respondents have confirmed the allotment at Rajakur. Aggrieved over the same, the petitioner has filed a writ petition in WP(MD) No.18766 of 2022 before this Court and the same was dismissed. Challenging the same, the petitioner has filed a writ appeal in W.A(MD) No.1256 of 2022 and the same is

pending. Pending the writ appeal, the petitioner has now made a request, seeking an allotment of house at Utchapatti Village, Thoppur, Madurai and filed this writ petition.
