ORDER : The Court made the following order :-

The petitioner/ Accused No.5 who apprehends arrest at the hands of the respondent police for the offences under Sections 272, 273, 328 of IPC in Crime No.354 of 2022, on the file of the respondent police, seeks anticipatory bail.

2. The case of the prosecution is that on 20.08.2022, when the respondent police were conducting vehicle check up in Sattur to Sivakasi Main Road, the Accused No.4 was coming from Sattur to Sivakasi in his vehicle. They made a search in that vehicle and found banned tobacco products. They recovered the contraband and registered the case.

3. The learned counsel for the petitioner submitted that the petitioner is an innocent, he has been falsely implicated in this case and he has not committed any offence as alleged by the prosecution. On the basis of the confession statement of the co-accused, he has been implicated in this case.

4. Learned Additional Public Prosecutor would submit that the petitioner is having one previous case of similar nature.
