3.The condition was imposed by the Principal District and Sessions Judge, Trichy. If the petitioners wants any modification or to set aside the condition, he must approach the concerned Court. Thereafter only he can move this Court.

4.This Criminal Original Petition is dismissed, directing the petitioner to approach the concerned Court seeking modification of any conditions, by filing appropriate petitions.
