This petition has been filed to modify the condition No.1 imposed on the petitioner in Crl.M.P.(MD) No.3918 of 2023 on 23.08.2023 by the learned Principal District and Sessions Judge, Tiruchirappalli.

2. The learned counsel for the petitioner submitted that the condition to deposit Rs.5,00,000/- has been imposed upon the petitioner. But, there is no overt act attributed against the petitioner. Already, the petitioner has filed the application for modification before the concerned Court on the very same ground in Cr.M.P.No.4206 of 2023, dated 05.09.2023, but the same was dismissed.

3. The learned Government Advocate (Crl.Side) submitted that totally Rs.41,00,000/- involved in this matter.

4. Even though it has been stated by the learned counsel for the petitioner that only limited overt act attributed against the petitioner, considering the huge amount that is involved in this matter, this Court is not inclined to modify the above said condition.

5. Hence, this Criminal Miscellaneous Petition is dismissed.
