ORDER

This Writ Petition is filed under Article 226 of the Constitution of India seeking for a Mandamus to the respondent police to grant the permission and protection for conducting the Vinayagar Chathurthi festival from 17.09.2023 to 19.09.2023 at Parthibanur, Ramanathapuram District.

2.When the matter was taken up for hearing, the learned Government Advocate (Crl.side) submits that the respondent police have already granted the permission on 13.09.2023 incorporating the route of procession, which was granted earlier. However, the petitioner wanted the procession to be taken through lanes, where the Mosque and Tharkas are existing.

3.The learned counsel for the petitioner submits that the petitioner will not press for grant of permission to take the procession through the lanes, where the Mosque and Tharkas are situated and it is suffice if the permission is granted as was granted last year.
