seeking for the issuance of Writ of Mandamus, to direct the 3rd respondent not to constitute Town Vending Committee under Section 22(1) of Street Vendors (Protection of Livelihood and Regulation of Street Vending) Act, 2014 in Palani Municipality and conduct of election schedule to be conducted on 30.12.2016 for electing 40% members representing street vendors to that proposed Town Vending Committee under Section 22(2)(d) of Street Vendors (Protection of Livelihood and Regulation of Street Vending) Act, 2014 without issuance of proper notice and without conducting of proper survey of petitioner and other street vendors, mobile vendors and stationary vendors doing vending in Sannathi Road at the bottom of Palani Temple and in and around of Palani Municipality on the basis of the representation sent by the petitioner dated 14.12.2016.
