Further, one previous case is pending against the petitioner, which is not similar in nature.

Taking into consideration of the submissions made by both the counsels, the condition imposed by this court in CrI.M.P(MD) No.7216 of 2023 in CrI.O.P.(MD) No.6009 of 2023 on 28.04.2023 is relaxed and since the final report has been filed before the concerned Court, the petitioner shall appear before the concerned committal Court on receipt of summons.
