ORDER

3. Taking into consideration the facts and circumstances of the case and also the materials that were placed before this Court, there shall be a direction to the fourth respondent to deal with the representation made by the petitioner on 20.09.2019 and pass orders on its own merits and in accordance with law, within a period of eight weeks from the date of receipt of a copy of this order. If there are any other interested parties, notice shall also be issued to them before final orders are passed. The petitioner is directed to make a fresh representation to the fourth respondent along with all the necessary documents and also a copy of this order.

4. This writ petition is disposed with the above directions. No costs. Consequently, connected miscellaneous petition is closed.
