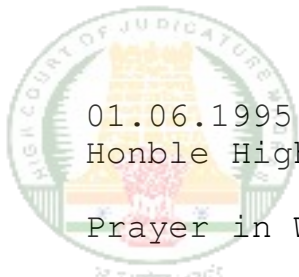

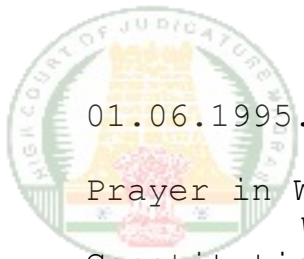

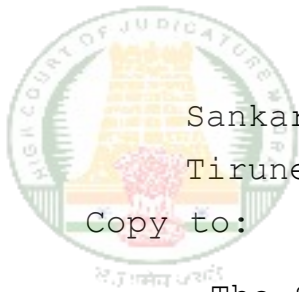
Prayer in WP(MD). 13674/ 2018 :
