records relating to the impugned Government orders issued by the 1st Respondent State Government in G.O.Ms.No.238, School Education, (Pa.Ka.6(1) Department dated 13-11-2018 and the consequential staff fixation settled by the 3rd Respondent CEO for the academic year 2018-2019 in Na.Ka.No.00/A1/2018 dated 00.02.2019 (signed on 18-02-2019) in so far as removing one post of General Mechanic in Teaching staff and two post of waterman from the staff fixation for the year 2018-2019 removal is concerned, Quash the same.
