The learned Judge, Family Court, Nagercoil, Kanyakumari District, is hereby directed not to insist upon the personal appearance of the respondent/husband herein, unless it is compulsorily required.

4. With the above observation, the Transfer Civil Miscellaneous Petition is allowed. No costs. Consequently, connected Miscellaneous Petition is closed.
