ORDER

The petitioner has filed this writ petition seeking a direction to the respondents to transfer the patta in his name, based on the Judgment and Decree passed in S.A.No.1495 of 1988 dated 09.07.2015.

2. Though the writ petition was filed in the year 2016, the respondents have not taken any action either to grant patta in the name of the petitioner nor filed any counter affidavit, assigning reasons for not granting patta in the name of the petitioner.

Therefore, the writ petition is allowed with cost of Rs.10,000/- (Rupees ten thousand only), which has to be paid to the petitioner by the concerned officer, who is responsible for not granting patta. The District Collector, Pudukkottai, shall pay the cost to the petitioner and recover the same from the concerned officer, who is responsible for not granting patta.

7. The respondents are directed to grant patta in the name of the petitioner within a period of four weeks from the date of receipt of a copy of this order.
