To Suspend the Sentence in judgment dt.22.12.2022 made in Criminal Appeal No.32 of 202 on the file of Principal District Judge, Karur confirming the order dt.23.2.2022 made in CC.No.649 of 2017 on the file of Judicial Magistrate(Fast Track Court), Karur Convicting the Petitioner for an offence under section 138 of the Negotiable Instruments Act and sentenced to undergo 2 years simple imprisonment and award compensation of Rs.2,00,000/- (Rupees Two Lakhs) in favour of the Respondent under section 357(3) of Cr.P.C pending disposal of the above Criminal Revision Petition on the file of this Hon'ble Court.

To call for records and set aside the Judgment dated.22.12.2022 made in Criminal Appeal No.32 of 2022 on the file of Principal District Judge,Karur confirming the Judgment dated.23.02.2022 made in CC.No.649 of 2017 on the file of Judicial Magistrate(Fast Track Court),Karur Convicting and sentencing to undergo simple imprisonment for 2 years for the offences under section 138 of the Negotiable Instruments Act and also directed to pay a sum of Rs.2,00,000/- to the complainant as a compensation u/s 357 Cr.P.C.within a period of one month and allow the said application.

Order : This criminal miscellaneous petition coming up for orders on this day, upon perusing the petition filed in support thereof and upon hearing the arguments of M/S.V.NAGARAJAN, Advocate for the petitioner and of MR.V.BALAJI, Advocate on behalf of the Respondent, the court made the following order:-
